SALA ARTIST REGISTRATION FEE SUBSIDY SCHEME 2021

SALA Artist Registration Fee Subsidy

This scheme acknowledges the role that artists and local venues play in the cultural life of the City of Onkaparinga. Subsidies of \$125 are available to assist individuals and groups with the cost of registering for the SALA Festival.

SUBSIDIES WILL BE PROVIDED:

- to artists who are residents of the City of Onkaparinga who are exhibiting either in or outside of the council area
- for costs associated with registrations for SALA, up to \$125
- to the first 24 applications received

ARTISTS ARE REQUIRED TO

- firstly register for SALA via the SALA website by the closing date of Monday 10 May 2021
- pay the relevant fee to SALA
- fill out this form including the Electronic Fund Transfer information
- fill in a Statement by a Supplier form, if not a holder of an Australian Business Number (ABN)
- attach a copy of their SALA registration receipt
- display the City of Onkaparinga 'supported by' logo on exhibition promotional material acknowledging the support, to be provided

ADDITIONAL INFORMATION AND KEY DATES

- applications will be dated in order of receipt and no correspondence will be entered into
- multiple applications may be considered
- subsidies will only be provided for costs associated with registrations for SALA 2021
- applications for the council subsidy close Monday 24 May 2021
- notification of application approval will be by Friday 4 June 2021
- the reimbursement will be processed according to council's payment procedure timeline

Late or incomplete submissions will not be accepted.

For your application to be considered all relevant information must be included along with accompanying forms and a copy of your SALA receipt.
