

SALA Participant Terms and Conditions 2022

This document contains the terms on which the Artist, Venue, or participant (**You**) will be registered with SA Living Artists Inc (ABN 36 876 104 708) (**We, Us or Our**) to participate as an independent artist or venue in the 2022 SALA Festival.

1. Acceptance

- 1.1 By registering your Event(s) in the 2022 SALA Festival, you are accepting to be bound by these terms and conditions (**terms**) and the SALA website terms and conditions which can be found on the SALA website.
 - 1.2 These terms are only for the 2022 SALA Festival and will apply until the later of 31 August 2022 or at the end of your Event(s).
 - 1.3 By registering your event(s) in 2022 SALA Festival you agree to complete an 'Artist and Venue Survey' provided by SALA Staff to you via email at the conclusion of the Festival.

2. Eligibility to Participate in SALA Festival

- 2.1 All Events registered in the 2022 SALA Festival must have at least 1 Artist participant who is a South Australian Living Artist. There is no limit on the amount of other participants in a 2022 SALA Festival Event but participants who are not South Australia Living Artists will not be eligible for consideration in the 2022 SALA Awards or listed in the SALA Festival Program. Events containing at least 1 South Australian Living Artist are eligible for consideration in the 2022 SALA Awards.
 - 2.2 A **South Australian Living Artist** is defined as someone who was alive and a resident of South Australia either at the time of registration for the 2022 SALA Festival or at the time of the 2022 SALA Festival itself.
 - 2.3 Artist is defined as someone who practices visual art. This can include painting, sculpture, drawing, photography, ceramics, textile, moving image and more. Other art forms such as music, dance, and theatre are not eligible for participation in SALA Festival unless in conjunction with an event that meets the **eligibility criteria set out in the SALA Terms and Conditions**.
 - 2.4 SALA Festival reserves the right to not accept any event registration which does not contain a South Australian Living Artist or to cancel the registration of any Event on that basis without any compensation to You.

3. Listings

- 3.1 As part of the registration process you will be provided with a summary of registration information detailing your Event(s) in the 2022 SALA Festival for publication in the 2022 SALA Festival Program, print and online.

- 3.2 You warrant that all information supplied to us in relation to your Event(s) has been reviewed by you and is accurate and correct. This also applies to any and all future information supplied to us by you. If at any time changes to that information occurs or you realise you have provided us information which is not accurate and correct, you undertake to immediately notify us of that fact.
- 3.3 By submitting images to us for use in relation to your Event(s) you warrant and undertake to us that you have obtained all necessary rights and permissions for the use of such images (including, where relevant, from the subjects) and you indemnify us against any legal action pertaining to the rights in relation to such images.
- 3.4 You have the opportunity to make changes to the information provided to us up to and including 11 May. If you ask for changes to your listing after 11 May, those changes may only be made at our sole discretion. If an early bird registration is submitted, changes made after the closing of the early bird deadline will incur a fee.
- 3.5 As the publishers of the SALA Festival Program and website we reserve the right to:-
- (a) edit listing copy or images that SALA Festival deems inappropriate for the general audience or otherwise for efficiency or clarity; and
 - (b) refuse to publish text or images that SALA Festival deems inappropriate for the general audience which the SALA Festival Program and website is intended to reach.
- 3.6 SALA Festival reserves the right to not accept the registration of your Event(s) or not accept any content or any material as part of your Event(s):-
- (a) that is liable to incite racial, ethnic or homophobic hatred or promotes hatred of any particular community or persons; or
 - (b) that constitutes or encourages conduct that would be considered as a criminal offence or is otherwise contrary to law including freedom of expression legislation and third party contractual rights;
 - (c) that breaches SALA's First Nations Rights Policy; or
 - (d) that is detrimental or is likely to cause damage to SALA Festival, its reputation, or its sponsors or stakeholders;
- or SALA may discontinue your Event at any time once it becomes aware of any such offending material or content without any compensation to You.
- 3.7 We will not be liable to any errors or omissions in the listings of your Event(s).
- 3.8 You must not misrepresent your exhibition or event as being sponsored by SALA Festival. The use of the terms 'SALA Award', 'SALA Artist in Residence', and/or 'SALA residency' are reserved for use in relation to events, activities and projects bound by separate contractual partnerships with SALA Festival.

4. Image Use and Offers

- 4.1 You agree to grant SALA Festival a non-exclusive perpetual licence at no cost to reproduce any images uploaded by You in the registration form or taken by authorised SALA Festival photographers, to market and publicise the SALA Festival. Artists and photographers will be acknowledged in any such publications.
- 4.2.1 You agree to receive offers from Us and Our partners.

5. Indemnity from You

- 5.1 You accept that You, your staff and other stakeholders participate in the 2022 SALA Festival wholly at your and their own risk. We are not liable for any loss or damage incurred by You, your staff or stakeholders.
- 5.2 You warrant to us that you have obtained all necessary licences and permissions from all parties interested in the copyright and other intellectual property rights whatsoever, and you indemnify us in respect of any claims, damage, loss, liabilities, costs, charges or expenses that are suffered or incurred by us as a result (whether directly or indirectly) of your failure to obtain any and all such necessary licences or permissions or to pay any relevant fees in relation to the same.
- 5.3 You indemnify us against any and all claims, actions, damage, loss, liabilities, costs, charges or expenses suffered or incurred by us as a result (whether directly or indirectly) of any act or default by You, your artists, venue, agents, employees or contractors in connection with the conduct of the Event(s) or the use of your venue for your Event(s).
- 5.4 You understand that You are wholly responsible for the safety of audience members and for arranging and paying for all insurances for your Event(s) including any public liability insurance.

6. General Conditions

6.1 GST

Any sum payable (or amount included in the calculation of the sum payable) or consideration to be provided, under or in accordance with these terms already includes an amount on account of GST where applicable.

6.2 Payment in respect of any taxable supply under this agreement is subject to:

- (a) a valid tax invoice being delivered to the Recipient for the supply; and
- (b) the supplier having provided notice in writing to the Recipient of its ABN.

6.3 Limit on Liability

- (a) All express and implied warranties, guarantees and conditions under Statute or general law as to merchantability, description, quality, suitability or fitness of any goods or services supplied by us for any purpose are expressly excluded to the extent this is possible and we will not be liable for physical or financial injury, loss or damage or for consequential loss or damage of any kind arising out of the supply, layout, assembly, installation or operation of the goods or services arising out of our negligence or in any other way whatsoever.
- (b) If any implied warranties cannot be excluded, then our liability is limited (at our discretion) to the resupply of the goods or services or to the amount of the registration fee.

6.4 Termination

- (a) We can terminate your participation in the 2022 Festival either with cause for breach of these terms without notice or without cause by notice to you and we will remove your Event(s) from the program for 2022 Festival. You are not entitled to

any compensation in the event of termination except, at SALA's complete discretion, the refund of your registration fee.

6.5 Interpretation

In these terms:

- (a) singular includes plural and vice versa and another grammatical form of a defined word or expression has a corresponding meaning;
- (b) reference to a person includes a natural person, corporation and partnership, body corporate, association, governmental or local authority or agency or other entity and vice versa;
- (c) headings do not effect interpretation and no rule of construction applies to the disadvantage of a party because that party put forward these terms or any portion of it;
- (d) if a provision of this Agreement would, but for this clause, be unenforceable, the provision must be read down to the extent necessary to avoid that result but if the provision cannot be read down to that extent it must be severed without effecting the validity and enforceability of the remainder of these terms;
- (e) reference to a party, if more than one, means each of them jointly and severally and includes the successor to the rights or obligations of that party under these terms;
- (f) a reference to a dollar or dollars is to Australian currency;
- (g) a reference to time is to Adelaide South Australia time;
- (h) references to "*includes*" or "*including*" or "*for example*" means without limitation;

6.6 Governing Law

These terms are governed by the law of South Australia and the Courts of South Australia have jurisdiction to determine any proceedings in relation to these terms.
